Abstract: The Hana and Charles Bruml papers consist of biographical materials, correspondence, personal narratives, photographic materials, printed materials, and Theresienstadt materials documenting Hana and Charles Bruml from Czechoslovakia, their families, their survival in Theresienstadt and Auschwitz, and their immigration to the United States after the Holocaust.

Acquisition information: Hana and Charles Bruml and Ruth Kraemer donated the Hana and Charles Bruml papers to the United States Holocaust Memorial Museum in 1989, 2000, 2001, and 2011. Accessions previously cataloged as 2000.354.1, 2001.3, and 2011.445.1 have been incorporated into this collection.

Custodial history: Hana and Charles Bruml made the 1989 donation directly. Ruth Kramer made the 2000 and 2001 donations as the executor of the Brumls' estate. In 2011, Kraemer donated five additional items in her own name that Hana Bruml had bequeathed her.

Related material: Separate oral history interviews with Hana Bruml and Charles Bruml (1990.355.1 and 1990.344.1) and separate video oral history interviews that form part of the USC Shoah Foundation Visual History collection can also be viewed onsite at the Museum. Hana and Charles Bruml also donated two drafting tools from Theresienstadt (1989.303.16 and 1989.303.17), wooden tile and toy created at Theresienstadt (1989.303.19 and 1989.303.20), watercolor (1989.303.21), spoon, burlap bag, and skirt from Auschwitz (1989.303.22 through 1989.303.24), concentration camp inmate uniform caps from Buna and Auschwitz (1989.303.25 a and b), homemade Czech badges (1989.303.26 and 1989.303.27), Mittelbau concentration camp scrip (1989.303.28 through 1989.303.35), trunk (1989.303.53), two Star of David badges (1989.303.54 and 1989.303.55), metal triangle bathroom pass from the Sackisch-Kudowa labor camp (1989.303.56), two drawings from Theresienstadt (1992.124.1 and 1992.124.2), a shirt and lab coat from Theresienstadt (2001.3.2 and 2001.3.3), two more Star of David badges (2001.3.4 and 2001.3.5), a sketch of inmates in a food line (2001.3.6), and 28 pieces of scrip from Theresienstadt (2001.3.7 through 2001.3.34). Charles Bruml is featured in the Museum's series of identification cards given to visitors to the Permanent Exhibition.

Biographical note

Hana Bruml (1922-2000) was born Hana Müller in Prague to metal smith and plumber Richard Müller (1885-1942) and Hedwig Müller (nee Zappner, 1891-1942). She was deported to Theresienstadt in 1942 and transferred to Auschwitz in 1944. Her first husband, Rudolf Schiff (1919-1943), was killed at Auschwitz, and her parents are believed to have been killed there as well. She worked in slave labor at Kudowa-Sackisch, a sub-camp of Gross-Rosen, and was liberated in May 1945 when her SS guards deserted her work gang. She changed her name to Hana Suk after the war and met Charles Bruml in Prague. She immigrated to the United States after the war and studied psychology at George Washington University.

Charles Bruml (1912-1998) was born Karel Bruml in Prague to shoe factory owner Jindrich Bruml (1882-?) and his wife Irma Bruml (nee Schindler, 1886-?). He was deported in 1941 to Theresienstadt, where he worked in the technical department, and then transferred to Auschwitz, where he painted numbers on prisoner uniforms. He survived a death march to Gleiwitz and a transfer to Dora-Nordhausen on an open coal wagon, and finally arrived at Bergen-Belsen, where he was liberated in the spring of 1945. He immigrated to the United States in 1946 and married Hana Müller. His uncle Richard Bruml was the secretary of the Social Democratic Party in Pilsen, was jailed at Schloss Nr. 1 in Rottenburg am Neckar for his political involvement, and died May 1942. Karel Fischer was Richard Bruml's brother in law and was an officer in the Austrian army in World War I. He was summoned to Theresienstadt as a specialist in

transportation and put in charge of road building in Theresienstadt and of the railroad from Buhusovice to Terezin. He survived, along with his wife and mother.

Scope and content of collection

The Hana and Charles Bruml papers consist of biographical materials, correspondence, personal narratives, photographic materials, printed materials, and Theresienstadt materials documenting Hana and Charles Bruml from Czechoslovakia, their families, their survival in Theresienstadt and Auschwitz, and their immigration to the United States after the Holocaust.

Biographical materials consist of birth, marriage, and death certificates; school records; identification papers; displaced persons records; and immigration and citizenship records documenting the Bruml family (Hana, Charles, Irma, Jindrich, Otto, and Richard), the Müller family (Richard and Hedwig), the Schiff family (Karel, Marta, Richard, Rudolf), Karel Fischer, and Bruno Mandl. This series also includes family trees; correspondence documenting efforts to trace the fates of member of the Müller, Schindler, Raiman, and Epstein families; immigration materials; and an untitled list of names including Karel Fischer's.

Correspondence files primarily comprise letters exchanged between Hana and Charles Bruml during the months between her immigration to the United States in May 1946 and their marriage at the end of the year. Additional postwar correspondence with family members, friends, and colleagues relates Holocaust experiences, documents immigration plans, and shares information about psychological investigations. A handful of 19th century letters to Julie Fraenkel convey birthday wishes from her husband and son. A postcard and letter from Karel Fischer document his World War I service in Przemyśl and postwar experiences in Vladivostok. Letters and telegrams document Richard Bruml's political imprisonment in Rottenburg am Neckar in 1941 and 1942 and his death. Postcards from Otto Bruml describe his life in Theresienstadt in 1943.

Personal narratives relate the Holocaust and immigration experiences of Charles Bruml, Edith Lowy, and three unidentified survivors. The narratives describe prewar life in Czechoslovakia, survival in Theresienstadt, Auschwitz, and the Skarżysko-Kamienna labor camp, and arrival in New York after the war.

Photographic materials consist of prewar and postwar photographs of family members and friends. This series also includes a photograph album, *Kultura v Terezine*, created by George Lauscher and documenting a memorial exhibition about Theresienstadt.

Printed materials include May 1945 copies of 21 Army Group News Bulletin and Die Mitteilungen, as well as clippings, articles, and speeches about the Holocaust. This series also includes an unbound copy of the pamphlet Jak si terezínští heftlinkové představovali, že bude vypadat československé státní zřízení, and a copy of an American Temperance Society display order form.

Theresienstadt materials comprise photostats and photocopies of drawings and maps of Theresienstadt, a road project for a street leading to a crematorium, and a report about food supplies and deaths at Theresienstadt dated March 1942. The drawings and maps were prepared by Charles Bruml in his role in the technical department at Theresienstadt.
