- 42. War Crimes Trials Pass, Visitor's Gallery, International Military Tribunal, session 153. signed by Rolf M. Wallerstein.
- 43. Documents (two copies), Nuremberg, Germany, 1945 Aug. 21. Printed by the Counter Intelligence Corps, U.S. Army and certified with a signature by Rolf M. Wallerstein. Reads: "I certify that the persons whose names appear above have been properly screened by this Detachment prior to being discharged from the German Armed Forces, and on this date, have affixed their signatures hereto in my presence." Signed by the persons being screened: Hermann Goering, Wilhelm Keitel, Alfred Jodl, Ernst Mantel, and Karl Doenitz.
