### **Biographical note**

Rudy Appel was born in Mannheim in 1925 to Julius and Rose Appel. Julius was arrested and sent to Dachau following Kristallnacht. Upon his release he immigrated to the United States to join his other son, Martin, who had immigrated a few years earlier. Rudy Appel was sent to the Netherlands for his safety, and Rose fled to Belgium. After the German invasion of the Netherlands, Rudy joined his mother in Belgium. They crossed into France en route to Marseilles, where they planned to take a ship to Cuba, but they were arrested near Angouleme and sent to Rivesaltes. Rudy was transferred to Les Milles around July 1942 but returned to Rivesaltes within two months. Two weeks later, in September 1942, he was transferred to Le Chambon sur Lignon where he was sheltered at the children's homes operated by Secours Suisse aux enfants at L'Abric and La Guespy to save him from deportation. He was reunited with his mother after the war, and they immigrated to the United States in 1946.
