Scope and content note: The papers consist of a document issued regarding the upcoming transport of Jews from Weimar, Germany, to Theresienstadt, Czechoslovakia, a document on luggage regulations for transport, a document regarding the collection of mattresses and suitcases, and three photographs of a memorial for Gentiles and Jews who were victims of the Nazis in the city of Suhl, Germany. All of the documents were issued in September 1942 by the Erfurt branch of the Reichsvereinigung der Juden in Deutschland [Reich Association of Jews in Germany].

Underneath the official stamp of the Erfurt branch of the district of Central Germany is the signature, in pencil of Ms. Schueftan, the widow of the local Rabbi, who ran this branch office and who issued the document to Daniel

Nussbaum. Daniel Nussbaum was the president of the Jewish Congregation of Suhl, a town about 50 miles west of Erfurt. The document is hand typed on the official city stationary of the Erfurt branch of the District of Sachsen-Thueringen.

- 2. Document of Important Notice regarding changes in luggage regulations of September 4, 1942 stating specific instructions of what type of articles and how many were allowed to be brought on a transport. Document is a mimeograph in blue ink issued by the Erfurt branch of the District of Central Germany of the Reich Association of Jews in Germany and accompanied a personalized order of transportation.
- 3. Document of Important Notice regarding the collecting of mattresses, suitcases, or knapsacks which should be sent to the Gestapo State Police of Weimar no later than September 17, 1942. Document is a mimeograph in blue ink issued by the Erfurt branch of the District of Central Germany of the Reich Association of Jews in Germany and accompanied a personalized order of transportation. A pencil inscription with the date September 11, 1942 is also present on the document.
- 4. 1 photoprint: b&w. Photograph in three parts of a memorial in the city of Suhl, Germany, for both gentiles and Jews who were victims of the Nazis.
