**Title:** William Ornstein papers, 1944-1970.

Extent: 23 folders 4 microfiche

**Provenance:** Most of the materials were found on and taken by William Ornstein from the premises of the Nazi concentration camp of Mauthausen after that camp's liberation. These materials were used by Ornstein as evidence in Nazi war crimes trials. After his death, his housekeeper, Felicja Olszewska, retained his papers for safekeeping. After Fay Brooks and other remaining members of Ornstein's family consulted, the papers were donated to the USHRI Archives in Sep 1993.

**Biographical/Historical Note:** William Ornstein was born in Drohobycz, Poland (now Ukraine) on February 16, 1915. During the Holocaust, he was a prisoner in Dachau and Mauthausen concentration camps. Following World War II, Ornstein appeared as a witness in various German courts and testified against several war criminals. He later immigrated to the United States where he died.
