The original documents reside at Yad Vashem, YIVO Institute for Jewish Research, the Central Archive for the History of the Jewish People (CAHJP), and the U.S. National Archives & Records Administration (NARA). The sole original pamphlet in the Milton Collection was purchased by the donor at a bookstore in Germany and was donated by her to the United States Holocaust Memorial Museum in November 1993.

Biographical/Historical Note: Sybil Milton served as a senior historian at the United States Holocaust Memorial Museum. The materials in this collection were gathered in the course of her research and then donated to the USHMM in 1993 and 1994. Milton was born in 1941 in the United States to Austrian refugees.

Scope and Content Note: The collection contains one original pamphlet, published by the USSR in German and Hebrew and appealing to Jews to support the initiatives of the Red Army. The bulk of the collection consists of photocopies of archival records dealing with the immigration of Jews to the Philippine Islands or with the treatment of those within the Third Reich the Nazis deemed "non-Aryan."

Among the collection are many reproductions of official United States Governmental correspondence pertaining to the immigration of Jewish refugees to the Philippines (1938-1940). They include declassified radiograms and interoffice correspondence between the U.S. Secretary of War, the U.S. Secretary of State, and the U.S. High Commissioner to the Philippine Islands, primarily concerned with tracking the popular and political response to the ongoing question of Jewish refugees entering the Philippines, and to requests for visas to be granted to specific individuals and their families. Other photocopies in the collection related to Jewish immigration to the Philippines are taken from contemporary newspaper articles, from the correspondence of the German Consulate in Manila with Berlin, and from the personal recollections of immigrant Margarete Stern.

The photocopies of archival records treating those deemed "non-Aryan" by the Third Reich include documents pertaining to "mixed-race" individuals, Roma, Jews, Slavs, and the mentally ill or infirm. This portion of the collection includes a photocopy of a 39-page volume found by Allied forces at Hartheim Castle; this booklet lists locations where those dubbed mentally or physically "infirm" by the Nazis were imprisoned during WWII, as well as charts and tables tracking the food rations allocated these prisoners during 1940 and 1941. The collection also houses duplicates of the official correspondence between municipal authorities and the *Deutsche Gemeindetag* in Berlin pertaining to the treatment/accommodation of mulattos [Negermischlingen] in Nazi Germany. (1936-1941) Finally, the collection includes copies of official Nazi correspondence and directives regarding the treatment of Roma in the Occupied East [Die Behandlung der Zigeuner in den besetzten Ostgebieten].
