Walter Michael Furman was born in 1924 in the United States. During World War II, he served with the United States military forces in Europe, and in 1945, traveled through Germany as a soldier, making stops at Dachau and Buchenwald concentration camps. Mr. Furman died in 2010 in Arizona.
