- .1 **Certificate**; "Certificate of Completion of Course" issued by ORT – UNRRA "Landsberg Jewish Center Professional-Trade School" issued to "Jakob Zimerman" [sic] (Jack Zimmermann) for completion of course in "Motor-car mechanic"; black and white photograph of recipient attached, circular blue ink stamp on bottom right corner: "World ORT Union/Germany" around outside, "c/o/UNRRA/U.S. Zone HQ/District/Office/Landsberg/(Lech)" on inside; dated May 25, 1946; Landsberg, Germany; in English

- .18b **Envelope**; for above letter; red, white, and blue Air Mail envelope addressed in green ink to "Mr./Zimerman Janek" [sic] (Jack Zimmermann ) in Landsberg-Lech DP Camp, preprinted return address from "I. Garfin/Department Store" in Edmonton, Alberta, three postage stamps adhered in upper right corner; verso: return address handwritten in green ink from "Mr. Sam Urison/10211-117 Str.,/Edmonton Alberta/Canada", black ink postmark; postmarked March 18, 1948; Edmonton, Alberta, Canada; in English and French
- .19 **Copy print**; modern black and white image of woman and two children standing outside (Malwina Zimmermann), Cesia Zimmermann, and Jack Zimmermann, mountains in background, boy leaning against white bear; original dated 1938; Hrebenow, Poland
