Biographical note

Moritz Henschel (1879-1946) was a World War I decorated (Iron Cross 2nd Class) veteran and graduate of the Berlin Rabbinical Seminary and a Jewish lawyer in Berlin. He served in the Landgericht in Berlin and was the last Vorsitzer (Head) of the Kehillah in Berlin. He and his wife, Hildegard Alexander Henschel (1897-1983), were deported from Berlin to Theresienstadt in June 1942. He was elected to the Theresienstadt Judenrat and was in charge of the "Freizeitgestaltung," under which auspices cultural events and materials were produced. Moritz and Hildegard survived Theresienstadt, in part because of food parcels sent to them from Sweden and by keeping a low profile. After the war, they emigrated to Palestine, where Moritz, already in poor health, died in 1946. Hildegard later testified at the Eichman Trial.

Scope and content of collection

Moritz and Hildegard Henschel papers consist of documents, poems, photographs, correspondence, clippings, articles, and sheet music pertaining to Moritz Henschel's role as director of the "Freizeitgestaltung," in Terezin and his wife Hildegard Henschel's experiences during this same time period.

Moritz and Hildegard Henschel biographical and Theresienstadt materials include birth and marriage certificates, Red Cross correspondence, employment records, awards, medical records, poems, music, reports, identification papers, personal narratives, and clippings documenting Moritz and Hildegard Henschel, their deportation to Theresienstadt, their cultural and work life in Theresienstadt, and their liberation.

Henschel family correspondence include prewar, wartime, and postwar family correspondence with Moritz and Hildegard Henschel, their daughter Lily, and Marianne Givol.

Research materials acquired at the Terezin memorial document Peter Kien. Family photographs document Moritz and Hildegard Henschel and the Jewish council at Theresienstadt. Additional award decorations and certificate document Shmuel Givol Gotthold.
