**Scope and Content:** Consists of copies of documents (many with English translations) written by Metropolitan Andrew Graf Szeptycki (Sheptytsky), the Metropolitan of Halicz and Archbishop of Lwow (Lviv). Includes two pastoral letters: the first was issued on July 1, 1941, the day of the German occupation of Lwow, while the second, entitled "Thou Shalt Not Kill," was issued in Nov.1942. Also included are signed and notarized depositions from witnesses attesting to the efforts of the Metropolitan to save Jews during the Holocaust, articles written about the Metropolitan and his brother, Ihumen Clement Szeptycki, copyprints, and correspondence related to attempts to have the Metropolitan named as Righteous Among the Nations by Yad Vashem.

The enclosed letter of the Studite Hieromonk Sebastian in Ukrainian describes the photo and identifies three Jewish boys. Daniel (Rotfeld), Dorko (Amarent), Levko (Chameides). The Studites risked their lives because only Jewish boys were circumcised, and therefore

easily identifiable by other children or by lay workers helping the monks take care of the children
