A letter from HIAS in Marseille, Dec. 16, 1940 to A. Friedheim:

"Received the affidavit sent by Mr. Davidson to the Consulate in Marseille. Want to make certain that Alfred Friedheim will remain at the address below." Signed, dated Dec. 20, 1940

Next several pages: numbers, address. Then a draft of a letter, in pencil:

"Glad to have met you. Since then my wife has become gravely ill and is in the hospital. I immediately notified the camp police (illegible). I would be most grateful if you would authorize my wife's staying with me until_____"

Pages of numbers; one line in English:"for hospital"

Next page filled with lines in green ink don't have a context or a clear content—just polite, very polite request to "leave the camp".

PORTUGAL

"The transit visa for Portugal cannot be issued until the receipt of a request addressed to the Portuguese government. In that request, which will be made by telegram through the auspices of

the Consulate, will contain the following: the destination according to the holder of the passport, or the visa issued by the Consulate of that country; travel reservation which must be sent directly to the Consulate by the agency in Lisbon, and which will indicate the name of the ship and the date of departure."

AMERICA

"An immigration visa is granted to a person who can submit proof that, once in the USA, this person will not likely become a charge of the American government. It is therefore indispensable to submit first the financial guaranties provided by relatives or friends domiciled in the US, with documents proving the veracity of the financial values indicated in the guaranties, or proof that the applicant currently owns money in the US, or property sufficient to support himself during an extended (undetermined) period of time. Obtaining a visa depends also on the availability of different quotas as related to the country of birth of the applicant. In general, one must foresee (this process to take) a relatively extended period of time, since the demand for immigration from practically all European countries is currently very high.

Documents that must be included in the dossier for immigration:

- 1 Financial affidavit, i.e. affidavits of support being provided, preferably by family members who are American citizens.
- 2 Guarantees of good moral and political standing, in the form of affidavits (notarized) from an American resident in the US. This citizen should guarantee the good moral standing of the immigrant and prove that the latter is not an agent of a foreign government who would engage in activities detrimental to the government of the United States. It would be preferable if the American citizen were to be someone at the Consulate.
- 3 Proof that an exit visa will be issued by the French authorities
- 4 Two (copies of) birth certificate
- 5 A marriage certificate (only for married women)"
