Acquisition information: David H. Pollock gave these papers to the U.S. Holocaust Memorial Museum on July 7, 1998. The U.S. Holocaust Memorial Museum Archives received these papers from the U.S. Holocaust Memorial Museum Collections department on November 9, 1998.

Scope and content of collection: David H. Pollock, a Canadian Jewish officer at Buchenwald soon after liberation, collected the names and addresses of relatives of liberated prisoners and wrote to them that their family members were still alive and needed their assistance. Due to his efforts, many Holocaust survivors were united with their families. Contains 18 letters and one newspaper clipping related to David H. Pollock's work to unite Holocaust survivors from Buchenwald with their families after liberation.
