Material passed on to People's Court, to be used in treason trials. Letter from chief prosecutor Berlin People's Court, to his counterpart at State Court in Vienna: how to deal with listening to foreign broadcasts. Other administrative court matters concerning treasonable acts, legal ramifications, etc. Poles accused of treason; other cases include treasonable acts benefiting Holland, Belgium, or France (September 1941).
