Scope and content of collection

Organization's information bulletins, as well as a May 1933 report of the statistical section of a Zionist organization in Berlin (Zentralausschuss der deutschen Juden für Hilfe und Aufbau), which argues against the claim that Jews were over-represented in institutions of higher learning. Also included are statistics on Jews by province, a monograph "Michel Ezofowicz" by S. Hirschfeld, and a list of books held by the Judeja Law Library in Vienna. There is also correspondence with Jewish student unions in Poland, Hungary, and Czechoslovakia on the calling of the First World Jewish Congress in Geneva, 1936 and Judeja representation as well preparation for the Second Congress, correspondence with Professor Sigmund Freud and D. Baumgarten on organizing lectures.

A May 1933 report prepared by the Statistical Section of the "Zentralausschuss der deutschen Juden für Hilfe und Aufbau." The report argues that the popular conception of an overrepresentation of Jews in higher institutes of learning is wrong. The same is true of elementary and middle schools. The report provides a statistical breakdown of Jews by province. Focuses on concentration of Jews in cities as compared with general population.
