# **Historical Note**

Główna Komisja Ścigania Zbrodni przeciwko Narodowi Polskiemu (Main Commission for the Investigation of Crimes against the Polish Nation), was established in 1945 and operated under the Polish Ministry of Justice. The purpose of the Main Commission for the Investigation of German Crimes in Poland was investigating the crimes committed by the Nazis on Polish soil and other occupied countries, and in Germany during the period 1939-1945. The Main Commission collected documentation, conducted investigations and prepared indictments, and publications. The Main Commission prepared investigations of all lawsuits against the Nazis, judged by the Supreme National Tribunal in Poland. Currently the Main Commission is a part of the Instytut Pamięci Narodowej–Komisja Ścigania Zbrodni przeciwko Narodowi Polskiemu (Institute of National Remembrance-Commission for the Prosecution of Crimes against the Polish Nation).

# **Scope and Content of Collection**

This collection contains investigation case files concerning labor camps for Jews, the murder of individual Jews, and the mass execution of Jews inside and outside the camps in various districts of the Poznań region. This documentation was collected by the Główna Komisja Ścigania Zbrodni przeciwko Narodowi Polskiemu (Main Commission for the Investigation of Crimes against the Polish Nation).

## **System of Arrangement**

Records are arranged in the original order of their acquisition from the source archive. The museum has acquired only selected records from Institute of National Remembrance (Instytut Pamięci Narodowej-Komisja Ścigania Zbrodni przeciwko Narodowi Polskiemu, or IPN). Request to investigate Kazimierz Antczar who notified the authorities in 1942 of the death of three Jews. June 1979.

Investigative report of Mieczysław Grzybowski about Łęczyca ghetto, mistreatment of Jews and non-Jews by the Gestapo. Jews forced by hunger to sell possessions. A mass execution in Łęczyca ghetto. survivors deported to Poddąbice. no date.

Mieczystaw Frontczak's testimony about removing Jews from better housing before incarceration in the ghetto. Mistreatment of Jews by a young Hitlerjugendboy; executions. Confiscation of possessions before deporting Łęczycz Jewish population to Chełmno. Witness is a retired teacher.

Four pages of Mieczystaw Frontczak's testimony about crimes against Poles and Jews in Łęczyca. Execution (by hanging) of ten Łęczyca Jews (for alleged commerce in foreign exchange) (similar to performed in other cities of Poznania). He gives the names of the ten persons on the German register books cause of death was geiven as "heart failure."

Illegible testimony of Kowalczyk Zdzisław. January 1980.

Numerous requests of the Regional Nazi crimes Investigation to round-up witnesses and speed up investigation about crimes against Polish Jews. January 1980.

Request of the Łódź NCI Office for copies of marriage certificates of Germans. Those documents are needed to investigate crimes in Łęczycz ghetto in 1940-1943. Name list of Germans who married in Łęczyca, their functions (in German); 77 names. April 1980.

Sixteen names of German officers in connection with Łęczycz ghetto.

Names of eighteen Germans from Łęczycz ghetto.

List of six German criminal police functionaries in the Łęczycz ghetto.

List of five Łęczyca prison German functionaries.

Request for marriage certificates of nine Germans (list) investigation purposes.

Request for ten death certificates of Polish Jews hanged in Łęczyca in March 1942, Jakok Chaim Lessman, allegedly died of heart attack before he reached the gallows and another unknown Jew was substituted. Correspondence. Ads in magazine for people to come forward with testimonies about the crimes against the Jews in Łęczyca.

Reprimand concerning investigation of witnesses to crimes against the Jews; forms not acceptable legally and internationally.

Investigative reports (on official forms) about Nazi the crimes against the Jews in Łęczyca. Łęczyca had 12,000 inhabitants, 5,000 Poles of mosaic faith. Jews were given dirtiest jobs, were in proportionally in high numbers among the 100 hostages, constantly humiliated, etc. Names of witnesses.

Request of Jakoa Lessman for date of death and cause (heart failure).

Copies of marriage, birth, and death certificates.

Jewish Historical Institute's relation of Wolf Bar Paciorkowski about Nazi crimes giving names of twelve police functionaries to be investigated. 1983.

Note about incarceration of Oskar Brannah accused of executing of ten Jews in Łeczyca and names of two other SS being sought. 1980.

Illegible German accounts concerning the death of ten people in Łęczyca.

Reprimand concerning testimonies of witnesses in crimes in Łęczyca. August 1983.

Extracts from German records about 11,937 Jews in Łęczyca.

Request for investigation of Nazi crimes in Wieluń, Poddębice, Piątek, Łęczyca, and Zelów.

Summary of and suspension of investigation in matter of Nazi atrocities in Łęczyca due to faulty information about the number of Jews. Gives dates as to Nazi mistreatment of Jews, September 1939 - February 1941.

February 1941 - 29 March 1942, liquidation of Łęczyca ghetto. After 1 September 1939, Łęczyca Jews were carried into a burning house and stabbed with bayonetts. Burning of an antique sunogogue, an establishment of the ghetto. Hangings in March 1942. Listing of crimes. List of Gestapo members from łęczyca. Unfortunately the investigation did not ascertain who committed the crimes and where the former Gestapo members are presently (1980); therefore the suspension.

The materials about the hanging of the ten will be forwarded to other offices for publication.

Testimony of Stefan Worobik who was allegedly witness to the murder of some 200 Jews before the liquidation of Łęczyca ghetto. He is asked as to the knowledge of perpetrators (list of names); living family members of the murdered and place of the burial. List of 176 murdered Jews in Żychlin (by profession or trade).

Four pages of correspondence concerning the murder of 200 Jews in Żychlin Worobik testifies about locating Jews (300-400) in buildings taken away from Poles and 4,500 in another ghetto. After year and a half the ghetto inhabitants were put on horse wagons and taken in direction of Kutno. He did not hear about any camp resistance. Civilians in yellow uniform called "yellows" were in charge of the ghetto. He does not have any documentation to substantiate his testimony.

Notes about the burial place of the murdered in Żychlin during ghetto liquidation. Few names about persons taking part in the liquidation and witnesses to the shooting. Names of probable witnesses to the tragedy.

Request to inform the authorities in Łódź if the burial place of the victims has been made memorable.

The Kutno court request for investigation of witnesses.

Testimony of Leon Czerwinski from  $\dot{Z}$ ychlin who witnessed transport of killed Jews to the cemetery. Liquidation of the ghetto in March 1942.

Twenty persons died preceding the liquidation. After the deportation of Jews to Kutno, two wagons with Jewish bodies were transported to the cemetery, buried after two to three days. March 1942, 40 more bodies were delivered to the cemetery (among the witness' baker Kotzei. He knows not who killed them.) Two Jewish women were shot in the cemetery and buried by the witness and neighbor. Refers to witness Czajkowska, wife of a Jew with whom she lived in the ghetto.

Testimony of witness Marcel Oliński pointing to gendarmes Cwiks and Graumer who helped to liquidate the ghetto. Names Volksdeutsche who were gendarmes in the ghetto.

Szyj Hamburg vel Stanisław Nowiński's testimony does not add much to the testimony of others, he did not live in Żychlin. He lost 40 family members during the ghetto liquidation.

Władysława Czajkowska Rozenberg, her convert husband and children were detained in Żychlin ghetto. She details the crimes committed against the Jews. Names victims and perpetrators. The husband arrested in hiding died in Auschwitz.

Request to interview three witnesses. All testify to the cruelties of the Volksdeutsche police who robbed and killed the Jews. 1967.

Summons report of the investigation of witnesses to the murder of 200 Jews in Żychlin in March 1942. Names of gendarmes.

Request for copies of list of victims.

Search for Fiszel Brajtsztajn.

Witness search. Requests for documents.

Testimony of Elżbieta Michalak staying in the ghetto with her former employee; testifies to seeing naked Jewish corpses in the cemetery killed by bullet in the back of the neck.

Testimony of Stanisław Stanicki and Michaloh.

Robberies in the Kutno ghetto.

Certificates of death of four Jews shot in 1947 by the Nazis.

Benjamin Majer Opatowski murdered in Żychlin, 28 February 1942.

Notes on the murder of 200 in Żychlin.

Testimony about the murder of Józef Urzędowski shot by a group of Nazis in September 1939 and the tortures of Jews of Żychlin.

Illegible testimonies. Searches for witnesses.

Testimony about the death of Szyia Mamburg, murdered in Żychlin ghetto in February 1942, buried in communal grave in Jewish cemetery in Żychlin.

Decision to consider and enter in the records as closed; application of Chaim Davidowicz investigation and decision to declare for dead (shot Symche Lejb Kesman in Zychlin ghetto).

Testimonies in case of Żychlin ghetto; all Jewish policemen were killed after the liquidation of ghetto; ending in "shocking picture of the Żychlin ghetto liquidation, existence and liquidation of each one of them are the same. Final purpose of it was to destroy the Jewish nation."

Request of Łódź court to interrogate witness mentioned in work of Rogalski "Occupation of Łódź Region."

List of ten Polish witnesses and their investigation report about Nazi atrocities against Jews; 36 death certificates issued after liquidation. 1972. 25 pages.

Request for and multiple copies of birth certificates of Germans. Poznań, 1973.

Correspondence, Żychlin ghetto of German policemen.

List of Jews murdered in Żychlin.

Correspondence urging submission of witness testimonies and reports about Żychlin. 1974. 26 pages.

Correspondence about the role of mayor of Żychlin, Hempel, in the killing of Jews. 1973. 6 pages.

Meeting of all Żychlin inhabitants in case of Żychlin ghetto. 2 April 1975. 16 pages.

Correspondence, alleged participants in Żychlin crimes SS or police actions in Żychlin. 14 pages.

Copies of death certificates. Requests for death certificates.

List of 115 names to be sent to German Court in Dortmund, against Hempel, former burgermeister of Żychlin. Witnesses' testimonies.

Correspondence: investigation of Polish witnesses; Jews from Żychlin who probably died in other places; names of Jews to be traced; Jewish witnesses who survived; to parish pastors about notifying people to come forward with testimonies about Żychlin ghetto. 1971.

Copies of photographs of Żychlin police station, gravestones, Hempel's house, general view of Jewish cemetery, panorama of the ghetto, killing place of Jews by Grohmann, police commando building.

List of witnesses' testimonies; death certificates of 92 Jews, 10 copies of marriage certificates.

List of victims murdered by SS and police in Żychlin ghetto, presented to Dortmund court; correspondence.

Correspondence about labor camp for Russian POWs. Poles building trenches.

6 Ds 17/67-13/67 Nazi crimes investigation, crimes against Poles of Mosaic faith (Jews). Punitive labor camp in Gidle (Radom district), August - October 1942. Population on the daily average 170 (1000 went through). Poles released 100 Jews who were then deported to Radom or Częstochowa. Investigation reports of witnesses about the treatment of Poles of Jewish faith. 54 pages.

Originally 2,000 Jews in Pajęczno. After September 1939 2,000 for transit camp Pajęczno, 1941-1943. Jews were deported to Germany for forced labor in the Wieluń direction. Names of German guards. Plan of Jewish transit camp. Death certificates. Names of those shot running away from execution place. Names of those shot in front of Catholic Church. Correspondence, affidavits, testimonies. List of death certificates (copies) for nineteen Jews. The Registrar's Office in Łódź has death certificates of Jews murdered in Działoszyce.

Case Dłubak Antoni accused of taking part in the killing of Jews escaping for Pajęczno ghetto. Copies of death certificates of his alleged victims. 65 pages. no date.

Case of Labor camp in Byczki district Radom, November 1944, closed on January 1945. Average number of detainees: 500, went through 2,500, mostly Poles from Głuchów working on military fortifications. One Pole killed during escape. Correspondence, investigation reports, death certificates. 124 pages and summary.

Jewish labor camp in Dąbrowice, 1942, liquidated in 1944. Dike work and fish pond. 300 persons. Deported after closing of camp. Women and children to Sikawa by Łódź men towards Warsaw. Case dismissed, Jews not maltreated or killed. 34 pages. 1967.

Nowy dwór camp - trench work. Only Poles, average of 4,000-12,000 all together. Deported when camp closed. August 1944 - November 1944. 25 pages.

Praszka, district Wieluń, 27 Jews executed 12 August 1942. Graves destroyed. Names of those executed. October 1943 German rural Police committed more murders in the Jewish cemetery. List of victims. Names of German commandant Waisenberg. Witness testimonies. During liquidation of the ghetto in fall of 1943, all sick Jews were executed by SS. Mass grave discovered in 1966. List of items found on victims. List of

ghetto inhabitants in Praszka: 605 persons. Correspondence, testimonies, death certificates.

Softysy, district Wieluń. Jewish labor camp: established January 1942, liquidated August 1942. Average 200. Road work, poor condition (12 hours per day), deported to Wieluń. Names of Germans. 46 pages.

Forced labor camp Głowno, district Łowicz (estate Zabrześnia), opened June 1943 and closed July 1943; for Polish males only; 45 persons to execute ground works. Transferred to Małoszyce; supervised by Polish police. Correspondence, testimonies. Disposition: discontinuance, no cases of murder, mistreatment, no escapes.

Forced labor camp Kamion, August 1944 - September 1944 for Poles only; for 5,000 people, total of 20,000 used for work on anti-tank trenches on the river Rawka. After closing workers were deported inland. Disposition: discontinuance. 15 apges of correspondence and testimony.

Michałów, district Skierniewce forced labor camp, opened 10 December 1944. Closed January 1945. Poles only, 300. Disposition: discontinuance. 14 pages.

Mierzyce, district Wieluń forced labor camp - total 9,000. Fortification work. Transferred to other labor camp. Correspondence, testimony, and disposition: discontinuance. Hard life, some beatings by Germans, no murders. 111 pages.

Bolimów ghetto. Opened in June 1940. Liquidated in March 1942. 1,500 prisoners from Bolimów, later from Łódź. Tailor and shoe makers shops in houses left by deported Poles. Guarded by Jewish police. Prisoners were leaving ghetto to obtain food from neighboring villages. Polish neighbors delivered food to poor Jewish families. Lists of ghetto inhabitants are not obtainable. Ghetto supervisor's Ostrowski and Koszwa are not known to the people of Bolimów, date August 1971. 35 pages of correspondence and testimony.

Ghetto in Borówka, subdivision of Głowno. Two Jews shot for wanting to escape ghetto's premises. In 1940, horses and wagons were confiscated to prevent border crossing by Jews and Poles. Adam Owczarek accused of denouncing Poles transporting Jews to Generalgouvernment. Map of ghetto in Borówka. 112 pages of correspondence and testimony.

List of ghetto camps and execution sites. Ministry of Culture and Arts. Monuments and places of remembrance of

Polish martyrdom, 1945 - 1946. Requests for documents, extracts from book on reparations. Correspondence. Copies of correspondence between the Polish Government in exile and its delegation in occupied

Poland, 15 November 1943. The Polish Government in Exile gave 2,695,000zt (= \$8,000) for the coordination committee of Bund and ZKN. Both groups need money on account of imminent extermination of Polish Jews. Beresowski (the Chief of the Committee) speaks about the need to preserve the priceless, social and cultural value that the still living Polish Jews represent. He wants to know how much money and who transferred to Poland as he did not receive any. There is the report of the Bund in London to the Polish Government Papers. Dr. Emanuel Szerer. It speaks of the Jewish situation. Financial accounting is included. 51 pages.

Application for a death certificate of Henryk Bernsztajz from Głowno. The summary of investigation it is noted that first to go to Warsaw ghetto were Jews who had valuable possessions taken from them in both installation. In the registrar's office no deaths are recorded. no date. 20 pages.

Correspondence, testimony. Death certificate for Sura Feldon and Lejzek Akawis in G\_owno ghetto.

Warta ghetto (district Sieradz)

Established February 1940, liquidation August 1943. Polish Jews expelled from Germany. Population 1,800 - 2,400. Provided own food. Employed as shoemakers, tailors, and road crews. Eleven persons executed; nine women deported to W\_yn and shot; sixteen killed by ghetto liquidation; 447 deported to Łódź; rest to Chełmno. Correspondence. List of German ghetto functionaries. Biała Rawska, ghetto. Ghetto was established in 1941 for Jews from Warsaw, Łódź, Żyradów, and Mszonowa. It counted 6,000 persons. Ten to fifteen Jews died every day from sickness or German bullets. Crimes in Przesław, district Brzeziny, on 31 October 1941.

Killing of nine Poles for alleged sabotage. Investigation suspended; German culprits not found.

Nazi crimes committed by Policemen from the police station of Bolimów on the inhabitants of villages. Jesiena, Bolimów, and Ziemiary, and Zator on 18 and 25 February 1944. Correspondence, investigation of witnesses reports, death certificates, and photographs of graves.

Gestapo and police murder people belonging to the underground.

Murder of inhabitants from Kamion (forest) district Skierniewice, 17 April 1944. Surviving witnesses reports of the mass death of Jews brought to Stutthof from Auschwitz, 1,300 daily and burnt on pyle.

Murders in Zator (five Poles). Report of a Jewish boy Majorowicz who having grown up joined the partisans and allegedly talked to others of conspirational press read by Pawłowaki and Co. (who were killed). Correspondence, witness testimonies, and death certificates. 85 pages.

Shooting of thirteen Poles by members of the Wehrmacht in September 1939. Only one name known: Stefan Nowakowski in Łowicz. German soldiers throwing incendiary bombs into houses, shooting at men, taking them into the synagogue. 227 pages.

Correspondence, testimonies, death certificates, maps, and pictures of sites.

Case combined with the persecution for crime of shooting six boyscouts in the brick factory (Najman's) by German soldiers.

Case of the Labor Camp in Siemkowice by Sieradz, Summer 1944 - 17 January 1945. Conditions poor, work hard but no murders. Case discontinued. 40 pages of correspondence and testimonies.

Murder of four Poles from Kurabki village, district Łowicz in October 1943 for harboring alleged members of the Polish underground forces. Case discontinued. The four died in the Pawiak prison. 1972. 60 pages.

Jewish cemetary and no information given as to why Skierniewice district: killing of a Pole in Słomków in September 1939, forest killing September 1943 of three Jews. Village of Zapady, forest killing in November 1943 of four Jews. In fall of 1943, four Poles were killed August 1944. Killing of one Pole in Makóv. Correspondence, investigation. 1987.

Wola Makowska, March 1944, one person burnt; one shot. Borysław, March 1944, one Pole killed. On the road between Prusy and Głochów, two Poles shot. In the forest by Maków, in September 1943, seven persons killed. Forest village of Maków, one Jewish woman and one Soviet POW shot. City park in Podtrzcianno, two Poles and one Jew shot, 1942 or 1943. "Zwierzyniecki" Las, August 1943, one young Jew shot. In Skierniewice, on Stroburowska street, one Jew shot. In Pamietno, one Pole killed. September 1943, in "Zwierzyniecki" Las, three Jews shot. In May 1943, eleven Jews shot in forest. In July, four people shot and in August 1943 thirteen Poles were shot in the same forest. May 1943, in Zwierzyniecki Las, two Jewish Poles shot. November 1944, three Poles shot in Zwierzyniecki Las. Summer 1943, a Jewish mother and daughter shot. october 1944, German police brought to Zwierzyniecki Las, two murdered victims. May 1944, one Pole shot. Pamietne October 1943, one pregnant woman shot. September 1944, twenty Poles executed in the forest. Correspondence, testimonies, death certificates, search warrants. 1987. 66 pages.

Mostki by Łowicz, December 1943, the partisans for "Maciek" section fought with the Germans and all thirteen died. December 1943, Gestapo, gendarmes, and policemen executed eleven Poles. no date. 68 pages.

Lubania, district Rawa Mazowiecka, 17 January 1945, one Pole shot by Wehrmacht. 1981. 22 pages.

Killing of four person from Trąbaczów district Rawa Mazowiecka, December 1943, by SS and rural police from Lubania for hiding Jews (names unknown). Correspondence, testimonies, and death certificates. 73 pages.

Killing of 40 persons, 17 Poles, rest Jews on September 1939, for alleged killing of two German soldiers in Rawa Mazowiecka. Some bodies buried in Jewish cemetary. Some names of Jewish victims. People stopped and herded in the market place. Some 2,000 Jews (males) were herded on local basketball court, later released. One witness saw 26 bodies, three Christians, among them. Germans demanded contribution of 25,000zt from the Jews. Rich Jews did not want to pay. The Jewish Committee reported it to the Germans, who deported 3-4 persons. Maków, district Skierniewice, rural police kills seven people in the woods and brings the bodies to Maków from Skierniewice, October 1943, seven hostages. In the same woods in Maków, one Jewish woman and one Soviet POW were killed in September 1943. Correspondence, testimonies, copies of death certificates, photographs of crime sites and plans; and names of Poles, Germans. In Polish. Investigation suspended 1976. 274 pages.

Poles killed, in Korabowice, German police from Skierniewice, June 1943 in the forest behind the village of Puszcza Mariańska. December 1943, the police entered houses and shot at people; eight persons killed. December 1943, the police burnt the farm of Jan Majerowicz (the name points to a Jewish person) and killed another man Henry Kowalska. Correspondence, testimonies, death certificates, and photographs. In Polish. no date. 130 pages.

In Rawa Mazowiecka, nine persons (one woman, one child, and eight Polish policemen) killed in January 1945 by German police from Rawa Mazowiecka. Bodies thrown into basement, and later exhumed. Cases: Soviet POW camps on Polish territory; forced labor camps in Nieborów, district Łowicz. Established in January 1942, closed in November 1942; camp inmates all Poles, 2,000. Worked on the river Bzura. After liquidation of camp prisoners moved to Łowicz-Małoszyce. In Polish.

Babichy, community leader, SS Jewish camp established in July 1944, closed in September 1944. Inmates returned to Łódź ghetto. Camp had a physician. 70 persons, all men. Two died and drowned in the river. Poles helped the Jews by throwing potatoes or bread slices over the fence. Correspondence, testimonies, birth certificates. 94 pages.

Camp in Ruda Pabianicka Bayer paper factory. October 1939 - June 1940 for Poles and Jews; about 2,000 passed through. Families fed the workers. One person killed during liquidation; remaining transferred to Ragodoszcze camp Sniec. From September 1939 to fall 1941, camp held Polish POWs, later Soviet POWs. 100,000 persons passed through this camp, including Warsaw uprising POWs in 1944. List of 200 people arrested upon denunciation by ethnic Germans in November 1939. Arrested were also the priests for the Ruda Pabianicka parish from Chojno; 50 priests were taken to Radogoszcze to amuse the Germans. The priests marched with heads shaven clean, huge black numbers on white sheets. After release from Radogoszcz they were all sent to Dachau concentratin camp.
