#### **Scope and Content of Collection**

Contains records from Auschwitz-Birkenau relating to the Office IV Department of Administration. Includes personnel paperwork, lists of the transfers of SS officers and of SS property, SS use of the tailor and cobbler services, driving permits, and the order and distribution of supplies, such as clothing, office supplies, and other miscellaneous goods. Includes lists of materials confiscated by prisoners and of the ordering of coal for the crematoria. Most of the paperwork includes the name of the member of the SS making the request. Includes an alphabetical, full list of SS-men.
