Scope and content of collection

The registration records of foreign nationals and personnel files of officers and other staff in the police headquarters in Łódź and a branch in Pabianice.

Historical note

Polizeipräsidium Litzmannstadt (Łódź) was established by the Police Main Office of the Third Reich (Hauptamt Ordnungspolizei) on Sept. 24, 1939. The office, along with its basic functions, had special tasks in the field of the consolidation of German language and culture, sowing terror and resettlement of Polish civilians, as well as solution of the so-called Jewish question. The executive organs of the Polizeipräsidium Litzmannstadt were: the protection police (Schutzpolizei, Schupo) and the auxiliary police (Hilfspolizei, Hipo), also the self-help squads (Selbstschutz). The Łódź prisons as well as the police prison on the Radogoszcz were also under its control. This office operated until its evacuation on Jan. 17, 1945.
