Provenance: From the National Council for the Study of the Securitate Archives (Consiliului National pentru Studierea Arhivelor Securitatii; CNSAS) in Romania. However records originate from the Archive of the Romanian Information Service (formerly called the Securitate; SRI). They were transferred to the Ministry of Justice, and kept in the Archives of the Military Courts (Arhiva Instantelor Militare) where they were under the dual subordination of the Ministry of Justice and the Ministry of Defense. Later, records were transferred to the National Council for the Study of the Securitate Archives. Copies of the cases were made after the transfer, and cases carry two numbers, the old number and the new CNSAS number. The United States Holocaust Memorial Museum Archives received the filmed collection from the National Council for the Study of the Study of the Study of the Securitate Archive via the United States Holocaust Museum International Archives Project in Nov. 2005.

Biographical/Historical note: Colonel Radu Dinulescu belonged to the Chief of Staff of then Romanian Army, Section II, and to the SSI. Section II of the Romanian Army was involved in the planning and execution of the ethnic cleansing of Jews in Bessarabia and Bucovina during the summer and fall of 1941. Col. Dinulescu, Chief of Section II, was personally involved in the enforcement of the order imposing the yellow star on the Jews in Bessarabia and Bucovina and certain areas in Moldova in August 1941 as well as in the planning of the pogrom of Iasi. He also was involved in implementing the Antonescu order to deport all Jews from Bessarabia to Transnistria within 10 days.
