The United States Holocaust Memorial Museum Archives received the microfilmed collection via the United States Holocaust Memorial Museum International Archives Project in Dec. 2002.

**Historical note:** Spain was ruled during the war by fascist dictator General Francisco Franco. Exhausted after its long and bloody Civil War, Spain was officially neutral or non-belligerent throughout the war. Ideologically, Spain was pro-Axis, and exported large quantities of war-critical tungsten to Germany. Spain severed diplomatic ties with Germany and Japan one month before V.E. day. Many Jews living in occupied Europe during the war took advantage of Spain's neutrality and sought visas to Spain. This was particularly true of Jews living in France. Once safely in Spain, many would continue on to Palestine or the United States, either directly from Spain or via Lisbon, Portugal.

**Restrictions on use:** No digitization of images is permitted without the written permission of the Spanish Ministry of Foreign Affairs.

**Organization and arrangement:** Thematic.

**Language:** Spanish, French, and English.

**Scope and content note:** The collection contains diverse documents from 1939 to 1963, concerning the situation for Jews in Europe in general, Spanish Jews, and individual cases of Jews seeking asylum in Spain. The bulk of the collection consists of correspondence related to securing transit visas to Spain for Jews attempting to escape Nazi persecution.
