Access: No restrictions on access.

Reproduction and Use: According to the terms of the United States-Hungary Agreement, personal data of an individual mentioned in the records must not be published sooner than 30 years following the death of the person concerned, or if the year of death is unknown, for 90 years following the birth of the person concerned, or if both dates are unknown, for 60 years following the date of issue of the archival material concerned. "Personal data" is defined as any data that can be related to a certain natural person ("person concerned"), and any conclusion that can be drawn from such data about the person concerned. Acquisition Information: Source of acquisition is the Magyar Országos Levéltár, MOL (Hungarian National Archives), Record Group MOL XIX L BEG (02). The Department of Compensation of the Hungarian General Banking and Trust Co. (Magyar Általános Értékforgalmi Bank Kártalanítási Osztály) closed its activities in the mid-1970s. The records created as of 1957 were first placed in the archives of the Financial Institutions Administration (Pénzügyintézet Központ) and subsequently transferred to the Ministry of Finance of Hungary (Pénzügyminisztérium Magyarország). In 1979 some documents were destroyed, for unknown reasons. In 1982 the Hungarian National Archives received 203 boxes of these materials, and an additional 1,712 archival units in 2008; the present collection, along with RG-39.024M, is part of that large transfer of Hungarian records to USHMM Archives. It is possible that some documents from this record group still remain in the possession of the Ministry of Finance of Hungary. The United States Holocaust Memorial Museum received the filmed collection via the United States Holocaust Memorial Museum International Archival Programs Division in 2009
