Provenance: The original documents were created by various Italian foreign missions in Europe; a Roman Catholic Church Official; the Italian Embassy in Athens; the Italian Army under Mussolini's pro-fascist regime; the President of the Jewish community of Spalato; and the Italian Ministry of Foreign Affairs from 1941 to 1943. Additionally, the report dated 1946 on the activities carried out by the Ministry of Foreign Affairs to protect the Jewish communities (1938-1943) contains copies of correspondence produced by Gestapo officials and other pro-fascists. The Italian Ministry of Foreign Affairs created the photocopies in this collection along with typescript inventories in English. These items were sent to the United States Holocaust Memorial Museum Archives in April 1993 via the Italian Embassy in Washington, D.C.

Organization and Arrangement: Organization is chronological. Divided into two series; <u>Series 1</u>: Correspondence, 1941-1943. <u>Series 2</u>: *Report on the Work of the Ministry of Foreign Affairs for the Protection of Jewish Communities During the Years 1938-1943*, 1946.

Language: Primarily in Italian with some French and German. English translations immediately follow each original foreign-language document or report.

Scope and Content: Primarily correspondence. Relates to the general treatment, incarceration, deportations, repatriation of Jews by the Nazis and Italian fascists in the
