**Scope and Content:** Contains records from the Archives of the Union Générale des Israélites de France (UGIF). Includes the files of Jewish social organizations integrated into UGIF by the Germans. Representative of the documents included are correspondence between constituent elements of UGIF, correspondence with French concentration camps, reports, statistics, legal

affidavits, and testimonies. The collection also includes records from Groupements de Travailleurs Étrangers (GTE), an organization concerned with foreign workers in France.

### **File CDX:**

Minutes of UGIF meetings, addresses and resumes of the heads of UGIF, and correspondence of the Director General of UGIF with UGIF's constituent elements.

### **File CDXI:**

Correspondence of the Director General concerning vacancies within UGIF, and other personnel matters.

Correspondence concerning the establishment of a single locale for the administrative offices of UGIF, associated lease agreements and legal documents pertaining to same, budget and balance sheets for UGIF operations, and correspondence related to personnel matters at the Lyon regional office.

### **File CDXVII:**

Reports from the Comité d'Assistance aux Réfugiés including information on arrivals, departures, countries represented, etc., lists of persons deported to various camps, monthly reports from the various bureaus of UGIF, and miscellaneous correspondence of the Director General.

Correspondence pertaining to individual case files.

Records from the Grand Rabinat de France Service de l'Instruction Religieuse de la Jeunesse.

Complete listing of all UGIF offices and affiliates in the Northern Zone, correspondence related to the reorganization/realignments of UGIF offices in the Southern Zone, and by-laws of the various organizations affiliated with UGIF.

Correspondence with Hungarian-Jewish aid organizations in France, correspondence with persons seeking the intercession of UGIF to aid and assist them with their plight, and correspondence of the Grand Rabbin (France).

Correspondence with various camps concerning the material provisioning of internees and miscellaneous correspondence regarding individual case files.

Personnel lists from the various bureaus.
