D 367 P34, Dossier 71: From the *Centres de séjour surveillé*. Death register from Natzweiler concentration camp, dated 1/4/1941 to 1/3/1944. (Apparently the carbon copy of D 311 bundle 17, article 53 above.) Approximately 100 frames.

D 409 Dossier 1: From a group of German files (D 409), dated 1940-1942, concerning French and Jewish civil servants and employees of the Bas-Rhin prefecture.
