Records include name, date and place of birth, and (occasionally) date of internment. The collection also includes information about the administration of the camps; arrests and deportations; the Commissariat for Jewish Affairs; and legislation concerning Jews and Freemasons.

Departure of foreign prisoners of the Jewish faith for the camp of Drancy (names of "foreign" Jews from Germany, Austria, Czechoslovakia, Poland, Esthonia, Lithuania, Latvia, Danzig, and Soviet Union, who entered France after January 1933). August 1942 convoys. Nominal lists. Methods of departure. 84 pages.

1831W92 Camp of Noé. 1944-1946. Officering personnel changes. Appointments. Resignations. Changes of status. Revocations. Applications for positions in the camp. Reports about situation in camp necessitating personnel changes. Depositions of prisoners about evading the camp with help from guards. Reports about conduct of personnel (black market, etc.). 309 pages.

1831W99 Center "Don Quichotte" at Portet S/Garonne. 1945-1946. List of names of Spanish people lodged in the center (1945-1946). Prefectural decrees of residence assignment for these people. In general, these people have obtained work authorization. Work permits. Reports mentioning the names of the individuals with whom they would be staying with. Other correspondence includes letters sent to people who lodge foreigners to present themselves to the Prefecture together with the foreigner. 271 pages.

Reports on application of legislation and ordinances, about the imprisonment of prisoners etc. Statistics about, arrests, liberations, categories of prisoners (according to nationality, i.e. French, German, foreigners, gypsies, prostitutes)(December 1944-November 1945). Spanish people that have entered illicitly and have been assigned residence (1946). Correspondence with the Prefect after the liberation, especially by people recounting their stories and whereabouts during the war or by authorities tracing people. 471 pages.

1831W112 Camp of Noé. February 22, 1945-February 9, 1946. Registers of exits. Statistics. Lists of names of prisoners with dates of arrest and liberation, nationality and observations. 272 pages.

1831W114 Camp of Noé. August 5, 1943-October 20, 1944. National Police. Register of order. The register contains notes of daily events in the camp, i.e. arrival, depart, and transfer of prisoners etc. 241 pages.

1831W115 Camp of Noé. 1941-1944. Lodged foreigners. Individual slips (letter M). Slip states name of prisoner, nationality, profession, address, marital situation, age, characteristics such as color of eyes, height etc., education, date of entry to France, date of entry to the camp, reason for imprisonment, political activities and party affiliation, observations (by camp inspector), condemnations. Reports of gendarmes about individuals. 762 pages.

1831W116 Camp of Noé. 1941-1944. Imprisoned foreigners, or foreigners assigned to house arrest. Individual forms (letters N, V, W). Slip states name of prisoner, nationality, profession, address, marital situation, age, characteristics such as color of eyes, height etc., education, date of entry to France, date of entry to the camp, reason for imprisonment, political activities and party affiliation, observations (by camp inspector), condemnations. 1037 pages.

### Reel 7:

2008W7 Vernet (Ariège) concentration camp for foreigners. 1940. Dispatch of money or packages to the communist elements of the camp. Police inquest. Police reports about evasions of prisoners; about the "Philanthropic Association of Quakers" allegedly used by communists in order to contact prisoners in the camp; about individuals who were smuggling train tickets or money in packages of clothes sent to the prisoners in the camp (some of these individuals belonging to the afore mentioned "Association of Quakers"). 31 pages.

2008W8 Weekly reports of the regional office of the Central Directorate of General Intelligence. October-December 1941. The reports describe exterior activities relating to prisoners in the concentration camps. Letters to prisoners in the camp. Letter regarding the creation of the "French Workers' and Peasants' Party" and "Open Letter to the Communist Workers" with names of individuals in the ranks and leadership of the party. Reports on how to limit contacts of prisoners with individuals outside the camp. 41 pages.

2008W9 Repression of antinational plots. 1940-1941. Surveillance of suspects. Police inquests. Police measures on encountering Jewish traders refugees in Toulouse. These refugees had come from Belgium (Bruxelles, Anvers) and the Parisian region and were of various nationalities, such as French, Belgian,

Polish, Austrian, German etc. Reports on illicit weapons traffic (weapons hid in dispatches of goods to Italian needy families in particular). 71 pages.

2008W10 Repression of Communist plots. 1941. Police operations in the communist circles of Toulouse, on December 10, 1941. Results of the operation (imprisonment of communists, their supporters, of foreigners). Newspaper clippings (La Depeche, Le Grand Echo) describing the measures that apparently were taken after attempts against the occupation army: For foreigners involved in crime, court martial and death. For Jews that arrived to France after 1936, camp imprisonment. For communists, massive arrests (of 1,850 people) that came after 11,000 other arrests during a six week period. Ministerial instructions. Report of the regional prefecture. 14 pages.

2008W41 General commissary on Jewish issues. 1941-1944. Regional directorate of Toulouse. Inquests and control section. Reports regarding commercial and other activities of Jews that reside in the region. Letter regarding baptismal certificates. Nomination of temporary administrators in Jewish companies. Newspaper clippings about the status of the Jews after the law of June 1941 restricting the "Jewish influence" in the administrative, political and socioeconomic life. Letters on behalf of individual Jews that were obliged to loose their companies or belongings. 392 pages.

2008W42 Military section of communications under German command. 1944. Copies of notifications addressed to the German general, who represents the Chief Commander "West" and accounts of the activities of the military section of communications. Permits to carry weapons for French people residing in the southern zone that work with the German forces. Report on bombing of French regions of the southern region by German airplanes. 139 pages.

2008W43 French section of communications of Toulouse in conjunction with the German communications. 1944. Statutes. Personnel. 25 pages.

2008W45 Relations of the regional Prefecture with the German military authorities. 1944. Correspondence regarding incidents (having to do with Germans, i.e. arson of farms), looting, arrests and executions of resistance fighters, and security measures. Order by Prefecture to Wermacht soldiers and to annexed services. 234 pages.

2008W114 Same as 2008W45 (i.e. Relations of the regional Prefecture with the German military authorities. April-Juin 1944. Correspondence regarding incidents (having to do with Germans, i.e. arson of farms), looting, arrests and executions of resistance fighters, and security measures. Order by Prefecture to Wermacht soldiers and to annexed services etc.). Lacunae: April 10-16, May 9-15, May 28-Juin 4, June 12-18, June 25 1944). 200 pages.

2008W184 French political or union personalities deemed dangerous for the national defense and the public security (reports with names and in particular Mr. Blum, Mr. Jules Moch, Mr. Leon Jouhaux, Mr. Paul Boncour etc.). Activities and surveillance by the Vichy regime in the Haute Garonne region. Police measures and residence assignments. Reports of police and regional Prefect. Pages 1194 and on contain reports about ex-Prime Minister Leon Blum, his residence assignment, his activities, surveillance of his telephone etc. 160 pages.

2008W187 Letters. 1936-1937. Anonymous letters addressed from Toulouse to Mr. and Ms. Leon Blum. Police inquest. These letters contain insults and threats. 20 pages.

2008W189 Orders of August 9, 1942. The orders are about the gathering of foreign Jews for the German authorities. 6 pages.

2008W191 Projected gathering by Vichy of Spanish people and of foreign and French Jews. These are to be sent to the camp Vernet and camp Gurs. Measures about execution of this plan. Concerns about secrecy since many lists of names do not have corresponding addresses. Telegrams among agencies trying to establish date for gatherings. Extraordinary meeting of prefects of the Toulouse region on this subject on May 19, 1944. 89 pages.

2008W207 German affairs. 1939-1942. War 1939-1945. Ministerial circulars. Measures for the protection of German and Italian commissions of control from attempts of local elements or from foreign forces. Relations with French administration. 42 pages.

1808W1 Camp of Noé. 1941-August 1944. Imprisoned foreigners, as well as French citizens. Liberation, transportation, or residence assignment of prisoners, as well as extension or other issues of their passports, identity cards, alimentation cards. These are dated in 1945. 890 pages.

1808W2 Camp of Noé. 1943-August 1944. Imprisoned foreign nationals (Spanish, Belgian). Nominal lists. Correspondence with camp administration and inquiries about prisoners in camp. 212 pages.

1808W16 Camp of Noé. 1953. Certificates of imprisonment, situation, status or previous deployment of prisoners delivered by the prefect of the Haute-Garonne. Requests for attestation of internment in the camp. 477 pages.

1808W17 Camp Saint Sulpice-La-Pointe (Tarn). 1941-1943. Demands for liberations and permissions. Reports about evasions of prisoners during transportation. 174 pages.

1808W18 Saint-Paul L'Eyjaux imprisonment camp (Haute-Vienne). 1941-1944. Permissions conceded. Individual files. 85 pages.

1813W7 Camp of Récébédou. April 1, 1942-October 14, 1942. Cooperative of prisoners. Cashier #2. Accounting book with daily accounting. 51 pages.

1813W9 Camp of Noé. January 10, 1944-1946. Alphabetical registration logs of departing foreigners. Reasons for departure. 106 pages.

1813W11 Camp of Récébédou. January 1942-April 1943. Accounting logs (receipts and expenses). 161 pages.

1813W13 Camp of Noé. October 4, 1941-November 30, 1942. Logs of foreign nationals entering the camp, mentioning provenance and date of entry. 59 pages.

1813W14 Camp of Noé. September 16, 1943-July 30, 1944. Logs of prisoners arriving to the camp, mentioning destination of prisoner. 109 pages.

1813W21 Camp of Récébédou. 1942. Accounting. 70 pages.

1813W34 Camp of Noé. August 1944-1946. Alphabetical register of departing foreigners, mentioning the date of departure from the camp, as well as date of birth, and nationality of prisoner, and observations. 73 pages.

1813W40 Camp of Récébédou. 1942. Accounting book. 60 pages.

1813W41 Camp of Récébédou. (Without date). Inventory of objects, furniture, cutlery at the camp. 70 pages.

1912W52 Camp of Récébédou. 1941. Financial situation (i.e. lack of alimentary cards for the prisoners resulting in hospitals in the city refusing to hospitalize the sick etc.). 26 pages.

1912W119 Idem. 1943-1944. (Camp of Récébédou. Financial situation (i.e. lack of alimentary cards for the prisoners resulting in hospitals in the city refusing to hospitalize the sick etc.)). Reports and declarations by prisoners and camp administration. 309 pages.

1912W139 Attempts against the German army. 1943. Sabotages. Explosions. Bombings. 393 pages.

### **Reel 8:**

This reel contains cards of administrative prisoners in the camp of Noé issued by the National Criminal Investigation Department from 1941 to 1945. Each file contains prisoners whose surname starts with a specific letter (Reel 8 contains letters A-F). The cards belong to French citizens and foreigners (Spanish, Belgian, Polish, Italian, Portuguese, German, Austrian, Yugoslavian, Russian etc.). The card states name and surname, place and date of birth, nationality, religion (Catholic, Jewish, Christian Orthodox, etc.), marital status, who is present in the camp (husband or/and wife or/and children), provenance, arrival date to the camp, lodging at the camp (number of building), liberation date (where applicable), possible transfer camp and date of transfer. Some cards of foreigners state date of entry to France. Various dates.

A.D.31-B Prisoners whose surname starts with the letter "B". 1654 pages.

A.D.31-C Prisoners whose surname starts with the letter "C". 834 pages.
