CCVII-1: Marbourg documents concerning the reports of February 1942 to October 1943 generated by the Recruitment Office for Belgian Workers Sent to Germany. 1942-1943.

CCVII-2: Marbourg documents consisting of blank forms, correspondence, and ordinances, dated January 1942 to August 1942. Also contains an ordinance dated 8 May 1942, concerning [the use of] Belgian labor in Germany. 1942.

CCVII-3: Marbourg documents, dated 1941 to 1944, consisting of notes, ordinances, and circulars concerning forced labor, particularly Jewish forced labor. 1941-1944.

CCVII-4: Marbourg and Majestic documents, dated 1940-1943, consisting of notes and circulars pertaining to organizing and mustering Jewish [forced] labor. 1940-1943.

CCVII-5: Letter, dated 25 October 1965, from M. P. Fassina, permanent representative for the International Research Service at Arolsen, to M. M. Mazor, the director of the archives of the Centre de Documentation Juive Contemporaine, concerning the name list of people deported from Malines and repatriated *via* the convoys of 4 August 1942 to 31 July 1944. 1942-1965.

Final report (number 4) completed in 1950, containing documents pertaining to the camp complex at Dannes-Camiers (Pas de Calais). 1943-1950.
