26W/12: Illegal border crossings made by Jews, between the French-Swiss border, 1942-1943 (A-G). Two files containing the particulars of individuals arrested [for illegal crossing]. Frames 1646-2679.

26W/13: Illegal border crossings made by Jews, between the French-Swiss border, 1942-1943 (H-Z). Frames 2680-3647.

41W/34: Illegal crossings on the French-Swiss border, 1940-1942. Three files titled "Foreigners of all nationalities; illegal crossings, investigations of the RG 1940-1942", "Poles; illegal crossings, investigations of the RG and individual files 1940-1942", and "Foreign workers incorporated into the work camps and Jews transferred into Todt in Marseille." 41W/38: Arrests and regroupings: Foreigners and foreign Jews, 1942-1943. Frames 1-1098.

41W/39: Regrouping of Jews into surveillance centers, 1942-1943. Frames 1099-1558.
