Source of acquisition is the Departmental Archives of L'Ain, (Archives départementales de l'Ain), Fond 180W, 1 Z, and 3 Z. and .The United States Holocaust Memorial Museum Archives received the collection via the United States Holocaust Memorial Museum's International Archives Project in December 2007.

Restrictions on access: No restrictions on access.

Restrictions on use: Permission must be received in writing from the directorate of the Ain archives for reproduction of microfilm reels.

Organization and arrangement: Arrangement is thematic.

Language: French, German

Scope and Content: This collection contains general information about “Jewish” affairs, Freemasons, identity documents, and internment. It includes documents specifically on the sub-prefectures of Belley and Nantua, as well as a list of “fugitive” foreigners.

Cataloger’s note: See additional documents of the Ain archives. They contain : Photocopies of documents from fond 180W not included on microfilm reel. Four-page name list of Jews present in the Department during the War, and Copies of published articles concerning the Holocaust in the Ain.

Two monographs published by the Departmental Historical Commission; one concerning the War and Holocaust in general and the other containing testimonies of deportees from the Ain are available in the Museum’s Library.
