40M/375: Roma interned during the occupation: the November 1944-February 1946 investigation; the Saint-Maurice-aux-Riches-Hommes camp in Yonne. Frames 2594-3173.

3Z6M/9: General Police File 1939-1945: Jews and Freemasons 1940-1944; regulations concerning foreign Jews crossing the demarcation line; political surveillance. Frames 3174-3264.
