Scope and Content: Contains lists of German women interned as enemy aliens, registered Jews, requisitioned Jewish businesses and buildings, individuals in need of psychiatric care, arrested persons, and foreign Jews living in Evreux. Materials include a card file for French Jews, a card file for foreigners, and files on Freemasons.

14W93: Jewish businesses. Frames 2388-3609.

1290W63: Requisitioned Jewish belongings, 1942. Frames 3610-3787.
