**Scope and Content:** Contains documents from the Jura, a mountainous, sparsely-populated region on the eastern border of France, once part of the Franche-Comté. The documents concern the anti-Jewish laws put into effect, certain Jews who held government jobs and were given special permission to keep

them, the cancellation of Vichy laws allowing lawful pillaging of Jewish property under "Aryanization", letters that singled out Jews in hiding to the authorities, documents dealing with foreigners who had been given exile in 1939, arrests of Jews by German authorities, and post-war Zionist youth camps.
