Provenance: The United States Holocaust Memorial Museum Archives received the collection from the Departmental Archives of the Deux-Sèvres, via the United States Holocaust Memorial Museum's International Archives Project in September 2010.

Restrictions on access: 206 pages are not yet open to the public and were reproduced separately. They come from 158 W 144 and 158 W 146. They will be transferred to the USHMM Archives when they are no longer classified. Some concern privacy issues for medical files. They will become available 75 years after the last date on a document. Some will be accessible in 2016.

Restrictions on use: Authorization from the Director of the Departmental Archives of the Deux-Sèvres required to duplicate microfilm reels for other archives. No publication of materials on the Internet, World Wide Web, or similar network without the permission of the Director of the Departmental Archives of the Deux-Sèvres.

Organization and arrangement: Arrangement is thematic.

Language: In French and German.

Preferred citation: Standard citation for the United States Holocaust Memorial Museum, Curatorial Affairs Division, Archives Branch.

Scope and Content: Contains records relating to refugees, including Italians; instructions concerning lists of Jews, their professions, and the confiscation of their property; the appointment of Aryan administrators; the confiscation of radios belonging to Jews; the distribution of Jewish stars; medical examinations of the Jewish population; and documents concerning Roma.

158W146: Arrests of Jews: official reports of the gendarmerie, correspondence, name lists, and the yellow star, 1942-1945. Internee Jews who escaped from the hospital: correspondence, reports, and police reports, 1944. Medical appointments of the Jewish population: medical certificates and correspondence, 1944. Hospitalizations: lists, investigation reports, and correspondence, 1944. Frames 1-317.

159W4: Foreigners and transferred Jews: name files, 1942. Frames 318-393.

1125W179: Gypsy anthropometric cards: Marie Debar's card with the notation "right to return to the Jarne camp 11 November 1940 before noon" as well as "released from the Allies camp in Angoulême, Charente on 30 May 1946. Frames 394-444.

1385W4: Jewish arrests: correspondence, orders, lists, registers, reports of the gendarmerie, and photos of bodies. Frames 445-1655.

1385W5: Census of Jews: lists and files, 1940-1944. Frames 1656-2845.

1385W6: List of people who are likely jurors for the French Indo-China court: orders, lists, and correspondence, 1936-1950. Frames 2846-3106.

1489W5: List of foreigners and Jews in the Bressuire district claiming to own Jewish businesses: correspondence, official reports, and reports from the gendarmerie and police, 1940-1943. Frames 3107-3168.
