INTRODUCTION

This status report¹ has been drawn up to provide readers with an inventory of the records available at SNCF for the 1939-1945 period.

Documents are stored at the Centre for Historical Archives in Le Mans and may be consulted by appointment² in its reading room.

To simplify research, the archives have been classified according to the branch of the company to which they relate³ and take the form of record sheets.

Record sheets

The record sheets are organised as follows:

- Sheets 1 to 4 relate to the Corporate Executive
- Sheets 5 to 11 concern the corporate functions
- Sheets 12 to 16 deal with the five SNCF Regions⁴ and provide details of contributions from the Regional divisions and their various sub-divisions

For each of these categories, readers will find the following information:

- A note on the organisation of the functions during the Second World War
- The contents of the archives for 1939-1945, extracted from the records as a whole⁵. In all, these amount to just over 400 linear metres of material⁶ described in this guide.
- A table showing the reference numbers and the numbers of cartons of records for 1939-1945.

The last two record sheets supply additional information. Sheet 17 provides references to the regulations governing the SNCF organisation. Sheet 18 highlights the vast wealth of documentary resources available.

Digitisation of the records for 1939-1945

Work on digitisation began in May 2011 and concerns all the records for the wartime period in the keeping of the Centre for Historical Archives in Le Mans. Some major themes stand out: relations with the occupying power, wartime operation of the company, statutory texts produced and decisions made by the Board of Directors between 1939 and 1945. All this adds up to just under

600,000 pages, which is more appropriate way of measuring the volume than in linear metres. In the end, very few cartons of records were digitised in full. It was, in fact, necessary to sift out those documents not relating to the period under consideration.

Since SNCF is insistent upon maintaining transparency with regard to all its documents and records, while remaining compliant with the rules in force governing the time that must elapse before their entry into the public domain, all the analyses made of the records kept for the period between 1939 and 1945 are available in the *Guide de recherches sur la Seconde Guerre mondiale* [Guide to Research on the Second World War].

Research material

The 112 different sources of documentary information in this status report have been carefully stored and may be easily accessed by those wishing to consult them. Some hard copy research material is available at the Centre for Historical Archives in Le Mans. For other material, it is necessary to go via the MAÏS application⁷, which may be accessed from the reading room (keyword "39-45"). Those interested should consult the appendix⁸ to this status report, which contains a table showing how each contribution received at the Centre has been handled.

The electronic version of the research material will soon be available on the SNCF Intranet.

Access conditions

Entry into the public domain

The SNCF archives are public property. They are therefore governed by the Act of 15 July 2008 outlined in Volume II of the *Code du Patrimoine* [Cultural Heritage Code].

However, indications regarding when these archives will enter the public domain given in the research material should be ignored. These have been superseded by new legislation. Unless otherwise specified in this guide, all the archives for the 1939-1945 period are freely accessible.

Some documents are, however, only available in electronic form, the originals being too fragile to stand up to frequent handling and also for greater convenience.

Exceptions

Records that contain personal information and those concerning railway accidents form an exception to the principle of free accessibility. Exceptions may, however, be made regarding their consultation before they officially enter the public domain. To obtain permission to consult the records concerned, an application must be made to the Archives Centre in Le Mans. This will have to be submitted to the French Inter-Ministerial Archives Department, which will reject or accept the application after consulting the authority that provided the material or is responsible for its conservation.

Secretariat to the Board of Directors and Executive Committee

The SNCF is managed by a Board of Directors and a Corporate Executive⁹.

It is the Board of Directors that has the greatest powers. During the Second World War, it was made up of 20 members¹⁰: ten representing the public authorities, five appointed by the Boards of Directors of the former private railway companies and five staff representatives proposed by the trade union organisations.

The archives from the Secretariat of the Board of Directors and Executive Committee offer a wealth of information for anyone wishing to conduct research into the history of the company.

Contents

Among the records relevant for study of the Second World War, mention may be made of:

- The company records of Board of Directors (final versions of minutes, meeting notes, working documents circulated, final agendas and provisional agendas with their corrections)
- · The company records of the SNCF Executive Committee until October 1940, when it ceased to exist (draft and final agendas, lists of attendees and absentees, working documents circulated, shorthand records of discussions, drafts and final texts of minutes)
- The company records of the Ordinary and Extraordinary General Meetings of SNCF shareholders (notification of and letters convening meetings, Reports from the Board of Directors to the Assembly, Auditors' reports, attendance sheets, placement diagrams, meeting notes, drafts and final texts of minutes)
- Company annual reports
- The correspondence of the Secretariat of the Board of Directors for the 39-45 period and a covering list of topics
- The files produced by the Secretariat of the Board of Directors for Board and Executive Committee members (excerpts from the minutes of the Board of Directors or Executive Committee, statutory texts and correspondence - in particular between SNCF and the Ministry of Public Works)

Secretariat to the Corporate Executive

The Secretariat to the Corporate Executive was responsible for incoming and outgoing mail, filing, archiving, links with regional divisions and corporate functions, file numbering, printing and circulating instructions and preparing official trips on behalf of the Chief Executive and his Deputy.

Contents

The importance of the topic-oriented files complied by this Secretariat as part of its routine activities should not be underestimated.

It is here in particular that the correspondence of Secretariat W, the special office of the Secretariat to the Corporate Executive, responsible for translating communications between SNCF and the German authorities, may be found peppering the various files.

In addition, there are large numbers of files relating to military affairs, and records from the Central Railway Commission dealing with preparations for war. Readers will also find information about commemorative events, the Legion of Honour, military medals and acts of courage.

Documents take a variety of different forms: letters, memos, orders issued by the Ministry, MOUs, agreements, decrees, orders, instructions, leaflets, acts, bills, programmes, papers.

In addition to this research material, readers may to consult the classification system for all the files at the Secretariat to the Corporate Executive, a plan that will enable them to search for data on the basis of fairly broad themes.

Access conditions

Claims Department

When SNCF was first founded, the Claims Department took over the role of the Joint Claims Department created in 1933 at the time of the major private French railway companies. It was responsible for examining the legal issues arising from railway operations, acting on behalf of the company in relation to all civil, administrative, penal and labour jurisdictions, and formalising all property transactions.

The Claims Department had three sub-divisions: a Legal Secretariat, a Commercial Affairs and Accidents sub-division and a sub-division for Civil, Administrative, Criminal and Fiscal affairs, all three further sub-divided into bureaux.

The material at our disposal stems from:

- the Legal Secretariat (I)
- the General Affairs bureau of the Legal Secretariat (II)
- the Bureau for accidents subject to ordinary law of the Commercial Affairs, Accidents,
 Criminal affairs and Insurance sub-division (III)

Contents

I) Case law rulings on the railways from 1939 to 1945

These records were compiled by the Joint Claims Department of the major private French railway companies, a task subsequently taken over by the Legal Secretariat.

The collections of rulings were designed to inform the various departments of the latest developments in case law, in order to avoid wasting time and money in taking cases unnecessarily to court.

Access conditions

II) Bureau of General Affairs

This bureau had the role of giving advice and investigating the various matters referred to it by the other sections of the Claims Division or the different SNCF Regions, advising staff and supervising developments in cases before the Council of State, the Prefecture Councils, the arbitration tribunals, criminal courts or the Court of Cassation (the highest appellate court).

III) Bureau for Accidents under ordinary law

The records in this case are those relating to claims connected with railway accidents affecting passengers or third parties, for all of the Regions taken together. They comprise accident reports, enquiry findings, letters exchanged between the Claims Department and the Regional Operating departments, expert medical reports, receipts and other documents in support of requests for refund of medical expenses, the pleas lodged by the SNCF lawyer or those acting on his behalf, copies of court rulings (ordinary, criminal or appeal courts), receipts for compensation paid to victims, records of payment of lawyers' fees, reports on such matters submitted to the SNCF Chief Executive by the Claims Department.

The Archive Centre in Le Mans keeps a list of information about the dates of all accidents, the places where they occurred and the Regions concerned. In addition, the ledgers for accidents from 1933 to 1978 are available on CD-ROM (0518LM002) and in aperture card form (0005LM842).

Access conditions

Given the nature of the data concerned, details will be made available at the request of the particular staff member or his dependents. It is however possible to request exceptional permission to view such documents.

Budget Department

Since it was first established in 1937, the Budget Department has come under the General Secretariat. Bylaw 2 of 1 January 1938 sets out its purpose as follows "responsible for drawing up the annual budgets, revising them on a quarterly basis, monitoring income and outgoings to warn of any risks of imbalance". It was also placed in charge of "tracking [...] the expenditure under the different budgets, checking [...] all cost allocations and verifying the asset position [...] of the different establishments."

In 1939, its activities were organised around three competence clusters: operating budget, investment budget and audits & enquiries. In 1941 the department underwent slight structural changes and was split into three sub-divisions: "General Affairs", "Operations" and "Investment"

Contents

A distinction may be made between the records for the operating and investment budgets, the investment plans of the different establishments, investment outlay and operating results.

There are also a number of documents, often produced by the Main Personnel Department, on the status of the workforce. These provide interesting input of a statistical and sociological nature for the period with which we are concerned, a difficult time for the company.

It is also worth remembering that these budget archives are the earliest for SNCF, recently nationalised at the time.

Access conditions

Main Technical Administration Department, subsequently Corporate Administrative Division

The Corporate Administrative Division was responsible for conducting studies into organisational issues¹⁵ at the request of the Chief Executive, and for the annual or future programmes of the SNCF¹⁶. It also had the task of centralising all questions relating to mechanised systems, statistics, technical documentation, transport production costs and the output of major rolling stock.

Contents

The records of the Corporate Administrative Division contain a large amount of Secretariat W correspondence¹⁷.

The issues addressed are many and various:

- Matters of general organisation, especially the organisation of relations with the German authorities in compliance with the Armistice Agreement
- Rolling stock issues: hire, orders and deliveries of rolling stock, especially to the German authorities; fleet numbers and rolling stock inventories; sums owed to SNCF for rolling stock utilisation; return of vehicles annexed by the Germans
- Fixed installations issues (track, buildings, structures): records on building, reconstruction and maintenance work conducted at the request of the occupying authorities
- Commercial issues: records regarding German or Allied transport movements (military or special, etc.) and their execution
- Operations issues: prevention of acts of sabotage in connection with train movements, protection of staff against air raids
- Financial matters: records connected with services provided by SNCF, especially to the German authorities (but also to the Allies), billing for such services and settlement of costs

The records also include:

- Documents on the railway detachment to the French occupation troops in Germany (preparatory phase)
- Memos setting out decisions made by the Chief Executive at the various conferences staged in the 39-45 period
- Records concerning the classification of statutory texts and archives

Access conditions

Main Personnel Department

From 30 October 1939, the Main Personnel Department Service was organised in two divisions:

- The Main Personnel Administration Division in charge of everything to do with staff, relations with trade unions, relations with the military authorities, staff administration and preparation of instructions
- The Main Social Services and Medical Division, also in charge of preventing accidents at work, staff leisure and housing issues

It should also be noted that a third main division was later established to deal with Pensions.

Contents

I) Staff records

The records contained in this collection deal with the following topics:

- Military affairs connected with the requisitioning of retirees and more generally with the mobilisation of manpower, retrenchment and repatriation of services, special allocation of employees, railway sections in the country
- · Aid granted to staff or the families of staff injured or killed in the war
- Decorations and awards
- · Files on staff relating to administrative purges

In addition, the records also include archives connected with communist and Free French (Gaullist) activities among railwaymen, disciplinary sanctions during the period, administrative purges, various amnesties, and end-of-war career reviews.

II) Named files

These contain information on index cards, compiled by the Main Personnel Department on the following subjects:

- Manpower developments
- War and occupation victims
- Railway resistance activities
- Sanctions applied to SNCF personnel
- Forced labour
- Purges

Conditions regarding access and consultation

Free access to records but, given their fragile nature, all hard copy documents have been digitised. These are available via hypertext links in the electronic version of the research material. Controls are in force as regards their reproduction. There are also three CD-ROM under reference 0518LM003.

Finance Department

During the Second World War, the Finance Department comprised two divisions: the Main Finance Division and the Main Accounts Division.

Most of the documents from that time originated in the Debt Clearance Bureau, which came under the General Ledger Sub-division, itself a part of the Main Accounts Division. This was the Sub-division responsible for centralising all SNCF accounting operations, financial accounts, monthly balances, settlement of year-end accounts.

Contents

In finance and accounting terms, the following are some of the issues emerging from the records of the Debt Clearance Bureau:

- Financial relations between SNCF and the French State and with other third parties:
 annual annuities payable or receivable, funds advanced by or repaid to the Treasury
- · Coverage of corporate expenditure
- Accounts opened in the company name, operating and miscellaneous other accounts
- Audits and financial supporting documents
- · Year-end settlement and final sign-off of the accounts
- Balances and ledgers
- Reconciliation of the accounts of the former private railway companies
- Copies of letters from the Debt Clearance Bureau and the General Ledger Sub-division.

Other records of interest to those studying the period include:

- Constitution, administration and organisation of SNCF
- Constitution and administration of the Société Anonyme Royale des Chemins de fer Guillaume Luxembourg
- Budget issues
- Tax issues
- Statistics
- International bodies and railways in other countries
- Matters connected with services performed for the German authorities

Conditions regarding access and consultation

Supplies, Orders and Contracts Department

The Supplies, Orders and Contracts Department was set up in 1937. It had five divisions¹⁸:

- The Supplies Division, which was responsible for handling all company supplies with the exception of fuels, which was the task of the Supplies Department.
- The Orders Division, which was in charge of procuring the products required by the Supplies Department.
- The Manufacturing Audit Division in charge of following up orders, technical supervision of
 works, compilation and adaptation of technical specifications not directly produced by the
 appropriate technical departments, albeit acting under their supervision. It also had the role
 of providing technical and sales information, etc. to the Supplies and Orders Department
 and to the Main Administration Department.
- The Fuel Division in charge of fuel supplies.
- The Contract Audit Division in charge of both producing standard rules for drafting contracts and for verifying all the contracts, of whatever nature, signed by SNCF.

In January 1939, a sixth division was created:

 The Electrical Power Division, whose role was to handle all aspects relating to the production, transport and distribution of high voltage current, purchase and sale of electrical power.

The Department was also responsible for managing the SNCF procurement accounts and supervising matters connected with industrial mobilisation.

In 1943, the department was renamed "Supplies Department".

Contents

The records have been obtained from the offices of Mr. Kipfer, who was a senior engineer in the Supplies, Orders and Contracts Department ¹⁹.

Documents cover aspects such as the role and workings of the department during and immediately after the Second World War under the following headings:

- Organisation of a supplies department in wartime
- Special allocations
- Weapons-related issues
- Department retrenchment
- Status of supplies at SNCF

- Role of the Organising Committees
- Signature of contracts and pricing regulations
- Relations with the German authorities
- · Relations with the Allied authorities

Conditions regarding access and consultation

Commercial Department

During the Second World War, the Commercial Department had four divisions: Passenger Traffic, Coordination, Freight Traffic, General Affairs & Advertising. These were responsible for agreeing and enforcing the services to be offered to customers, in association with the other branches of the Corporate Executive.

When it was first set up, the Commercial Department was therefore in charge of both passengers and freight. It was in 1976 that it split into two parts: the Passenger Commercial Department (renamed the Main-Line Department in 1992) and the Freight Commercial Department (renamed the Freight Department in 1991).

Contents

I) Corporate Passenger Traffic Division

This division had the task of monitoring passenger traffic sales and ensuring the follow-up of major issues such as fare structures. In the records, readers will be able to find details of changes made in passenger fares at the time and application of the different fare scales.

These archives consist of wartime and peacetime passenger transport schedules, for most of the French administrative areas (*départements*)

III) Communications materials

1) Collections of posters

Readers will be interested to know that there exist a number of advertising and propaganda posters for the 1939-1945 period. All posters published during the war had to bear the reference ORAFF followed by a series of figures, this reference having to be an integral part of the printed document. This was the stamp of the "Office de répartition de l'affichage", a supervisory body created by the German authorities in November 1941 and under their control.

Posters deal with the following main topics:

- Safety
- The battle for coal
- Solidarity week
- Theft
- Sabotage of locomotives

Some of them were published in magazines but these are not kept at the Le Mans Centre. Readers will find an inventory of these posters in the research material.

2) Brochures

These are cardboard-backed advertising documents originally filed by the Commercial Department together with details of the number of copies printed.

- · Freight advertising brochures
- Tourist brochures

Main Fixed Installations (and Construction) Department

This department was responsible for infrastructure, track and trackside equipment, level crossings, bridges & tunnels, electrical installations, telecommunications, signal boxes and other safety installations. It had the task of designing and having construction and major modification works carried out in response to requests from the Regions and branches of the Corporate Executive. It was also responsible for maintenance policy and methods. In 1972, its name was changed to Civil Engineering Department.

For the moment, we have very few archives for the 39-45 period from this department to recommend to readers: a few odd files collected by Raymond Amisse of the Civil Engineering Department (General Studies Division) and interface with the Railway Museum in Mulhouse.

Contents

The records available concern a variety of topics:

- · Construction or upgrading work on various lines
- Track alignment and maintenance
- Civil engineering structures
- Fixed equipment (technical documents)
- Training for District Managers and managers responsible for Track & Buildings in the SNCF Regions

Access conditions

Main Traffic Department

This department was renamed Transport Department in 1972, before changing its name once again to Infrastructure Department in 1995. In conjunction with the Commercial Departments, the Traffic Department was involved in preparing the services to be marketed vis-à-vis the customer. It was responsible for organisation all passenger and freight transport movements and for supervising their execution. In this capacity, it decided on the resources required, in both quality and quantity terms and in association with the relevant branches of the Corporate Executive: station and line facilities and equipment, and transport activities for those establishments with dual Rolling Stock and Transport functions. In association with railways in other countries, it agreed the general conditions for the use of these resources (in particular the rules on safety and workforce deployment) and was generally in charge of monitoring all train movements. In addition, it organised and coordinated efforts to prevent theft and fraud.

Contents

I) Operating Systems Division, Central Division for Regulations and Safety

The records contained in this collection address the following issues:

- Preparation of safety regulations or instructions for the regions
- Examination of regional enquiry reports into accidents and incidents.

When it was first established, SNCF was made up of a Corporate Executive, Main Departments and Regional Divisions. In 1938, all the lines on the network were split between 5 Regions²¹ - East, North, West, South-East, South-West²² - all headquartered in Paris. Their existence bore witness to the company's involvement in the Regions.

Each Regional Division had three main departments: Traction & Rolling Stock, Track & Buildings and Operations.

The Operations Directors heading the individual SNCF Regions were answerable to the Chief Executive as regards ensuring rail services, issuing orders to staff, maintaining close contacts with customers and their authorised representatives, proposing or introducing all measures to boost traffic, enhance services and ensure cost-effective operations. They were responsible for executing the orders or instructions of the Chief Executive, or those issued in his name by the Main Department Directors.

The Regions were then divided into sectors: MT (Traction & Rolling Stock²³), EX (Operations), VB (Track & Buildings²⁴). These covered two or three sub-sectors and were headed by a Sector Manager.

Track & Buildings is the source of the majority of the archives for the North Region kept at the Centre in Le Mans.
