Scope and Content: This collection contains records generated by German occupational institutions (Reichsprotektorat Böhmen, Mähren) and Czech auxiliary agencies dealing with matters of internal security and racial policy, especially anti-Jewish measures. Includes reports regarding aryanization of Jewish businesses, questionnaires of Jewish properties, lists of Jewish workers, documents regarding situation in Theresienstadt (death statistics), Lety camp (typhus), and deportation of Jews to Theresienstadt. Also includes lists of art objects in Sbirow castle (including Jewish art), information regarding Jews, gypsies and Russians in Gdańsk (Poland) and various propaganda materials.
