Historical Note

The British Colonial Office, Palestine, was responsible for the civil administration of Palestine from 1918 to the expiration of British Mandate and subsequent Declaration of the Establishment of the State of Israel on 14 May 1948

Scope and Content of Collection

Includes correspondence relating to British policy in Palestine, e.g., discussions with the Jewish Agency, other Jewish organizations, and individuals as well as world reaction to policy; petitions; Arab opposition and disturbances; Jewish immigration issues, granting visas, settlements, and illegal immigration; logistical/administrative concerns relating to public works, police, railways, and other infrastructure concerns; financial issues in Palestine; the Royal Commission on Palestine, Partition Commission, Jordan Valley Authority, and implementation of the United Nations Organizations Decision.

System of Arrangement

This collection is arranged in numeric order by the record group, series, and folder numbers used by the National Archive. All files belong to record group CO 733, and are subdivided first by series number, and then numerically by file number within each series.
