#### **Historical note**

The British Federation of University Women assisted refugee academics persecuted by the Nazis The British Federation of University Women (BFUW) was founded in 1907, to "afford a means of communication and of united action in matters affecting the interest of women". In 1992 it was renamed the British Federation of Women Graduates (BFWG). The current organization "seeks to promote opportunities for women in education, and public life more generally" and provides "graduate women living in England, Scotland and Wales with information, support and friendship, at local, regional, national and international levels. Conferences, meetings, networks and social events, at all levels, are open to all members." The BFWG is affiliated to the International Federation of University Women (IFUW), of which it was a founder member, and University Women of Europe (UWE).

- Mrs. Anna Thurman: Protestant; industrial chemist, 1941-4?
- Ilse Ursell: German Jew; student; later worked for BBC and Institute for Protection of Science and Learning, 1941-51.
- Dr Gertrud Wachtel: Austrian; cv, testimonials; refugee, 1938; correspondence, with Hospitality Sub-Committee, Co-ordinating Committee for Refugees, 1939-46.
- Frau Kaete Warnschauer: Jewish; mainly in German, 1939.
- Dr Helene Weiss: German Jew; refugee from 1937; publication of book on Aristotle, 1939-45.
- Alice Weissbruth: British (b. Russia); arrived 1931, 1947.
- Henriette Werner: Austrian; socialist from working class family; grant needed for youth club leader training; receipt for clothing, 1944-5.

- Leo and Gerty Wiener (sister of Dr Hollitscher): accommodation problems; Newby Bridge Committee, 1940-43.
- Dr Gertrude Willner: Czech (naturalized British); request for clothing for German mining students, 1947.
- Dr Charlotte Wittelshoefer, nee Hirsch: German Jew; pediatrician; arrived Aug. 1939, 1941-?
- Dr Alma Wittlin: stateless (Austrian); grant needed for research fees, 1942-50.

- Erika Wodak: Yugoslav (Liberal Jew; training as youth leader), 1941-42.
- Dr Irene Wurmfeld: Czech Jew; inventor (with husband) of foot-loom for use by handicapped children; needs grant to replace model and/or employment, 1940-?
