Biographical/Historical Note: Marcel Henri Jaspar (1901 - 1982) was a doctor in law and liberal member of parliament (1932-1944) in the Brussels district, Belgian politician and minister. Jaspar was a minister of transportation (1936-1937) and health (1939-1940). Marcel-Henri Jaspar was the youngest of the ministers of the Belgian government in exile in Bordeaux in June 1940. After the war he pursued a diplomatic career, he became Belgian ambassador in Prague, Buenos Aires, Rio de Janeiro, Stockholm and Paris .

Scope and Content Note: Contains selected records of the Marcel Henri Jaspar collection. Includes minutes of meetings of the Ministry of Public Health regarding the evacuation of the civilian population and correspondence and diplomatic notes.
