- 2.12 Describes Ukrainians slaughtering Jews.
- 2.33 She is giving birth to her son and stays with friendly Ukrainian family. Hunger.
- 2.46 Is interrogated by the Gestapo and released.
- 2.58 Describes big "Action" in Turka.
- 3.04 Describes her escape with husband and baby to Hungary.
- 3.22 Sends baby to peasants in Munkash to be saved.

- 3.28 Train ride to Budapest and arrival.
- 3.49 She and her husband go to a refugee camp under assumed identities passing as Hungarians (non-Jews). Went by the name of Rosie Burger.
