In this interview, Alexandrs Škļars, born October 28, 1933, and a native of Daugavpils, a small town in present-day Latvia, talks about an execution of local Jews. This is an event he witnessed at the time of the Nazi occupation of his village during World War II.

Škļars introduces himself; says that at the time of German occupation he lived in Daugavpils; says many Jews were friends of his family and that he was always in good relations with the local Jews; remembers a night toward the end of 1941: their Jewish neighbors (an entire family) were taken away and soon afterward their house and shop were looted by locals; discusses the railroads carrying Wehrmacht troops eastward, and headed west were captives and refugees [?]; says many (of the latter) did not survive the transport and their corpses were gathered at a small park in town and were eventually taken away; says that the German soldiers were not as stolid as they are often portrayed; says they would give the locals chocolate; describes a summer day in which he witnessed a large procession of the local Jews (more than 300 people) escorted by an armed convoy; says the soldiers wore Wehrmacht-like uniforms, but more plain; says that between the locals it was rumored that the Jews in the procession had to throw their jewlry away; says the procession went toward the **Stropski** Forest to a three-story brick building near the Golden Mountain; says that around 1 a.m., machine guns began firing and went through 5 a.m.; says later on that morning he went to the execution site because he wanted to find a jackknife; says there were many other locals looking for jewlry; remembers seeing a large pile of torn Soviet paper money.

Škļars says his family had good relations with their Jewish neighbors; says his mother often purchased items in the neighbor's shop on credit; says his father also enjoyed the respect of Daugavpils Jews; returns to the procession discussed earlier; describes the convoy; tells that he was standing there about 20 meters from the procession; says that the Jews in the procession were of various ages; says that the people in the procession were carrying their belongings; says that some threw their jewelery; says one woman in the procession threw her jewelry and it was immediately picked up by a man standing on the roadside; says he does not remember if among the Jews in the procession were any he knew personally; says the machine guns did not begin to fire immediately after the procession was moved away which was around 3 p.m., but rather around 1 a.m. the next day and continued until 5 a.m.; remembers hearing the shots clearly because his house was standing within half a kilometer from the execution site; says that later in the morning the place was clear, except for the pile of torn Soviet bills; says that he was there with his neighbor **Dimka Kupriyanov** the next

morning; says that some people searching the site afterwards found a lot of gold and became rich; notes that his parents never looked for the gold or jewelery there; says he does not remember any of the convoy soldiers returning to the village after the execution took place, nor does he know if any of his acquaintances were executed; says he could not understand the language of the soldiers and that the soldiers were drunk.

After being asked on how big the mass grave at the execution place was, Škļars answers that there were several graves; says the clearing in the forest was about 60 by 80 meters; says he was there for about two hours, and after not finding what he wanted, went back home; says there were about 15 other people, mainly locals that he knew personally who were searching as well; says he talked with some of them, but nobody would tell him about what they found.
